Over the last 20 years I have gained extensive experience working with adults with acquired brain injury and a range of neurological conditions. They often have comorbidities including physical and/or mental health problems. I particularly enjoy interdisciplinary working, and have worked within community neurorehabilitation teams, and inpatient brain injury units, supporting individuals and their families through rehabilitation, and in long-term care placements. I have highly developed skills in completing mental capacity assessments on a range of issues, and I facilitate reflective practice and supervision for staff groups and colleagues. I am highly competent at delivering training specifically designed to increase understanding into a particular clinical approach, theoretical underpinnings, or in formulating a clients' presentation. I can support teams in understanding behaviours of concern, developing positive behaviour support plans and risk assessments, as well as in facilitating trauma informed care. I have experience of working through interpreters in providing therapy.

In my role with Newby Psychological Services I complete specialist neuropsychological assessments and provide neuropsychologically based rehabilitation for clients who have suffered an acquired brain injury. This can also involve interdisciplinary working and the provision of training. I also carry out complex assessments of client's mental capacity to make a range of decisions. These include testamentary capacity, capacity to manage property and affairs, to engage in sexual relations and to make decisions regarding their care and support.

February 2019 - present

I lead the neuropsychological assessment and rehabilitation provision across two brain injury inpatient services; St Cyril's Rehabilitation Unit on the Countess of Chester Health Park, and Derby House in Liverpool. I also provide clinical psychology and consultation input to a residential learning disability service for clients with complex needs. I complete supervision of Assistant Psychologists and other psychological colleagues. I design and then deliver client bespoke training to staff as required to increase their understanding and skills in supporting clients' neuropsychological needs. Interventions involve direct client work, work with families and carers, as well as with teams/systems. I undertake regular mental capacity assessments for a range of decision-making processes. These include consent for care and treatment, decisions around place of residence, management of finances/appointing of LPAs, consent for medical procedures, capacity to make decisions around feeding at risk, and testamentary capacity. I have undergone PBS training and lead on the development and review of Positive Behaviour Support plans for the clients with learning disabilities.

November 2013 – February 2019

I provided psychological assessment and interventions to clients with acquired brain injury or progressive neurological conditions. This was part of the pathway for the Cheshire and Merseyside Rehabilitation Network.

I provided psychological assessment and intervention across two community neuro-rehabilitation teams (the Star Team covering Stockport, and SpRINT covering Tameside and Glossop). The ethos of the service was to provide interventions to support clients to reach their own goals, and to support them in the long-term adjustment to their condition.
